## MEMORANDUM OF UNDERSTANDING



This Memorandum of Understanding (MoU) is made and executed on / / 2024, at Satara, Maharashtra, India, by and between

**YSPM's, Yashoda Technical Campus, Faculty of Pharmacy, Satara (YTC)**, having its registered office at S. No. 242/1, on NH 4 By Pass, Near Wadhe, Satara (Pin - 415011) Dist: Satara, India

**And**

**Department of Botany, Shrimant Bhiyyasaheb Rajemane Mahavidyalaya, Mhaswad, Tal. Man, Dist. Satara**

### **WHEREAS**

Dept. of Botany, Shrimant Bhiyyasaheb Rajemane Mahavidyalaya, Mhaswad and YSPM's, Yashoda Technical Campus, Faculty of Pharmacy, Satara desire to promote and develop cooperation in Technical Skill development, Student & Faculty industrial training, Placement, Industrial visits, project work, and research intend by this MoU to establish and operate a mutually agreed program to establish an effective and long-standing alliance.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions herein contained, the parties hereto agree as follows:

### **OBJECTIVES**

**The principal Objectives of this MoU are:**

- Enhancing and enriching research culture among the students.
- Providing research training to the students/faculties.
- Organizing various development workshops/conferences/seminars for the students and staff by exchanging human resources.
- Explore students' projects in areas of mutual interest and explore opportunities for research exposure of the students.
- Organizing college visits for students to correlate their academic knowledge to current practices going in the industry.
- Provide a platform for research in an educational complex of YTC
- Explore YTC utilities for respective colleges in the desired ways.



## Expectations from the Parties



**Responsibilities of Dept. of Botany, Shrimant Bhiyyasaheb Rajemane Mahavidyalaya, Mhaswad:**

Both parties agree that **Dept. of Botany, Shrimant Bhiyyasaheb Rajemane Mahavidyalaya, Mhaswad** shall provide the following support to **YTC**:

- Furnishing technical support through value-added programs.
- Training and other exposure through Guest lectures, Project work, Industrial Visits, and Placement Events.

### **Responsibilities of YTC:**

Both parties agree that **YTC** shall provide the following support to **Dept. of Botany, Shrimant Bhiyyasaheb Rajemane Mahavidyalaya, Mhaswad**

- The research activities will be carried out by providing adequate and reliable infrastructure and hospitality.
- Performing supportive documentary work on the activities at YTC.
- Securing coordination and other supports provided by the **Dept. of Botany, Shrimant Bhiyyasaheb Rajemane Mahavidyalaya, Mhaswad** relevant to the training, projects, research, and other relevant activities.

### Execution and Operational Review:

- **YTC and Dept. of Botany, Shrimant Bhiyyasaheb Rajemane Mahavidyalaya, Mhaswad** will review the operations of the program yearly. The purpose of the review shall be to assess the planning and operations of the program including, but not limited to its quality, timeline, performance, and progress. The subject of expansion and amplification of the scope of this MoU will also be discussed during the review meeting.

### General Provisions:

- 1) The parties shall discuss and finalize the detailed scope of work to be performed by each party for each assignment and agree on all considerations for the same.
- 2) Except as agreed above neither party shall make a claim against the other party for any expenditure unless such expenditure has been agreed upon in writing between the parties.
- 3) The implementation of the areas and forms of cooperation identified in this MoU shall be subject to the availability and convenience of faculty, research scholars, students, and infrastructure facilities at the parties' workplace.

### Relationship of the Parties:

This MoU is not intended to create a relationship such as a partnership, joint venture, or agency. Neither party may act in a manner that expresses or implies a relationship other than an independent contractor, nor bind the other party. Participation in this MoU shall not prevent either party from entering into similar MoUs with other institutions.








### Validity:

Unless extended by the Parties in writing this MoU shall remain valid and effective for Three (03) years from the date of execution, hereof, and can be extended for a further period of Two (02) years. Either Party may terminate this MoU by sending a prior written notice of not less than one (01) month.

- This MoU supersedes any prior oral or written understandings and constitutes the entire MoU between the parties with respect to its subject matter and no modification, amendment or waiver thereof shall be effective unless in writing and signed by both parties.
- Neither party shall make any claim against or be liable to the other for any loss or damage including but not limited to any consequential damages or loss of profits arising from any discussions, or actions taken in reliance on this MoU.
- Each person executing this MoU warrants and represents that he/she has the authority to enter into this MoU on behalf of the party whose name appears above their signature.
